



Details on papers for Clinical Health Promotion

Original studies (IMRaD*):	Up to 3000 words and 50 references
Abstract	Up to 220 words
Reviews	Up to 4500 words and 100 references
Abstract	Up to 220 words
(All reviews should include a description on the search for evidence)	
Best Practice and Education	Up to 800 words (600 words and 1-2 figures and tables)
Editorials	800-1200 words and 10 references
Others	Up to 700 words and 5 references
(Cases, PhD thesis, comments)

Reference style in Clinical Health Promotion

- References in the text are to be cited sequentially in the Vancouver numbering style. Please use Arabic numbers in brackets. E.g. ... first defined by Nielsen and Small (5).
- Two references are cited separated by a semicolon, with no space between (2;5). Three or more consecutive references are given as a range with a hyphen between the numbers. E.g.: (5-8)
- References in tables, figures, and panels should be in numerical order according to their place in the text

The reference list should be performed according to the guidelines stated by the ICMJE-group (www.icmje.org). For Clinical Health Promotion the following exceptions apply:

- If there are six authors or fewer, please fill in all authors; surname space initials comma. E.g.: Thompson KA, Larsson C.
- If there are seven or more give the names of the first three, followed by et al. If there are more than six authors on a given publication, only the first three authors should be stated in the reference list followed by "et al."
Punctuation mark after the name of the journal.
No issue number of the journal, only volume number and page numbers.
- Journal titles should be abbreviated according to MEDLINE (www.nlm.nih.gov).

Example on reference list:

• Laan MT, van Dijk MC, Staal MJ, et al. Electrical modulation of the sympathetic nervous system in order to augment cerebral blood flow: a protocol for an experimental study. BMJ Open 2011; 1:e000120.

Figures and tables

When presenting exact data use a table, whereas a graph is more adequate when the aim is to illustrate a tendency. Avoid three-dimensional presentations.

Do not present your data twice (e.g. in text and table or figure). Illustrations should be submitted in the original format, e.g. as PowerPoint or Excel files and pictures in jpg or tiff format.

All illustrations should be submitted as separate files. If an illustration has been published before, we need a written permission from the copyright holder if the illustration is going to be reproduced in your article. We strongly encourage the submission of illustrations including photographs.

- Figures should be attached in additional files preferably in .pdf (Alternatively .pgn or .jpg and in high resolution, 300 dpi or higher.)
- Descriptive text allows up to 30 words per figure or table.
- We urge all authors to consider the use of tables. If possible all tables should be attached in .doc format, otherwise preferably in .pgn or .jpg and in high resolution; 300 dpi or higher.

Authors

Authors should fulfil all four criteria for authorship set by the International Committee of Medical Journal Editors (ICMJE-group at www.icmje.org). This has to be stated in the authorship declaration and should be submitted with the article.

Authorship credit should be based on

The ICMJE recommends that authorship be based on the following four criteria:

- 1) Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work; AND
- 2) Drafting the work or revising it critically for important intellectual content; AND
- 3) Final approval of the version to be published; AND
- 4) Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

Authors should meet conditions 1, 2, 3 and 4.



Each of the authors' contribution could be presented as follows:

Conception and design: TLS, HP.

Acquisition of data: TLS.

Analysis and interpretation of data: TLS, HP.

Drafting, revising and final approving of the article: TLS, HP.

Contributorship

Contributors who meet fewer than all four of the above criteria for authorship should not be listed as authors, but they should be acknowledged. Those whose contributions do not justify authorship may be acknowledged individually or together as a group under a single heading.

Conflicts of interest

Any conflicts of interests for the submitted paper in the form of an "ICMJE Uniform Disclosure Form for Potential Conflicts of Interest" ([Link to Col form](#)) should be submitted for each author of the paper. These forms should be submitted when sent with the article. The Col forms will be made visible in the online archive of all published articles.

Trial registration

All studies, which include human subjects, should be registered on an open web-site such as e.g. www.clinicaltrials.gov. The registration number should be included in the abstract of the original article or protocol article after "funding" as well as in the methods section in the paper.

Copyright

Articles published in Clinical Health Promotion are "open access". This means that the articles are distributed under the terms of the Creative Commons Attribution Non-commercial License, which permits any non-commercial use, distribution, and reproduction in any medium, provided the original author(s) and source are credited.
